

Information sheet: national visa

Visa for skilled workers with vocational training qualification (Section 18a Residence Act)

Basic information

- Documents not in the English language must be submitted with a certified German translation. A translation of the personal data page of the passport is, however, not required.
- Certificates, diplomas, etc. must be presented in the original. Your original documents will be returned to you once your application has been processed.
- The visa must be approved by the Federal Employment Agency and, where applicable, the competent foreigners authority in Germany. The visa can only be issued when these approvals have been received.
- Processing time is as a rule ca. 4 weeks but can take longer in individual cases.
- Flight reservations are not required to apply for a visa please only book when you have received your visa.
- The mission abroad reserves the right to request further documents.
- Missing documentation delays the procedure and can result in your application being rejected.
- Please do not contact the mission abroad to check the status of your application during the normal processing period. Such inquiries are extremely time-consuming for the visa section and can thus not be answered.
- Please do not staple the documents.


General information

As a <u>skilled worker with vocational training qualification</u>, you can be issued with a residence permit to engage in <u>skilled employment</u> that your qualification enables you to perform.


Please note that some university degrees from foreign universities are classified as vocational training qualifications in Germany.

Use the following checklist to make sure your application documents are complete. All documents listed here are to be submitted in the requested form and order.



Visa application checklist				
The following documents are to be submitted in full with every application.

One (1) fully completed and signed application including declaration pursuant to Section 54 Residence Act				
One (1) recent biometric passport photo (see specimen photos)				
Valid and personally signed passport with at least two completely empty pages				
One (1) uncertified copy of the data page of your valid passport				
Completed form signed by your employer: <u>Declaration of employment</u> (original with one (1) copy)				
From the age of 45: Proof of adequate provision for old age (original and one (1) copy (only if salary does not amount to at least 55% of the annual contribution assessment ceiling for the general pension insurance scheme – 2025: 53 130 € gross/per annum))				
Notification of recognition of foreign vocational training: Written notification of the agency responsible for recognition of vocations in Germany (original and one (1) copy)				
or (in the case of regulated professions in which permission is required to exercise the profession, for example, in the care sector; complete list is available from the <u>Federal Employment Agency</u> or the <u>European Commission</u>)				
Permission to exercise a profession issued by the authority responsible for recognising qualifications or assurance of permission to exercise a profession (original and one (1) copy) (for example, for medical professions)

Proof of qualification, for example, diplomas, certificates, work log with translation				
and proof of completion (original and one (1) copy)				
Proof of adequate health insurance cover				
If as an employee you are subject to mandatory statutory health insurance, you must bear in mind that this insurance can only begin when you take up residence in Germany and enter into employment. If you enter Germany beforehand, private health insurance must be taken out for the period prior to employment beginning and prior to being eligible for statutory health insurance. In its terms and conditions, travel health insurance can exclude protection if a long-term or permanent stay is planned. So-called incoming travel insurance can also contain such exclusions.
